2403/02 **Declarations of Interest**

Cllr Hughes declared a Personal Interest in Item 2403/10 Application 78254.

2403/03 **Public Participation**

A member of the public asked if the current defibrillator is registered as they could not find it on the national database and the nearest one online shows as Pilton. It was noted that it is registered and if someone was to ring 999 in an emergency they would be directed to the defibrillator (assuming it is their nearest).

2403/04 **Minutes**

It was **resolved**, with no votes to the contrary, to approve and sign the minutes of the Parish Council meeting held on Thursday 22nd February 2024 as a correct record.

2403/05 County Councillor Report

Cllr Maskell reported that the main road to Ashford from Heanton is a mess, there is an issue with mud and debris from the field and DCC is now working with the EA to find a solution. DCC has been awarded £5million for road safety improvements from Barnstaple to Ilfracombe and the crossing over the A361 has been put forward as a scheme although it is not official yet.

2403/06 **District Councillor Report**

Cllr Knight reported that a link had been circulated in relation to the Devon, Cornwall and Isles of Scilly Adaptation Strategy and he urged Cllrs to read the information. NDC has asked District Cllrs to push to Town & Parish Councils, there is a good synopsis and covers Climate impact up to 2050.

2403/07 Highway Priorities

a) To appoint a new Snow Warden.

It was noted that a volunteer had not been identified. It was agreed to place on the website.

2403/12 Highways and Footpaths

The Chairman reported that since Christmas he has reported six separate issues to Devon County Council in relation to highway and footpath issues in the Parish as follows:

- Give way sign.
- Flood water on the top road although clear at the moment.
- Ashfield Lane collapse not bad enough for anything to be done.
- Slippery footpath no action.
- Long Lane collapsing bank has been done, although it is the bare minimum to open the footpath.
- Second tree up from the Garden Centre evergreen oak not been updated on the website.

It was agreed to send the list and reference numbers to Cllr Maskell.
